January is a slower month for the Club from a transaction standpoint. For the month we have the "normal" recurring revenue generators of the Spirit Store and Concession stands. Also in January we started to collected funds for the February Fundraiser. Also we got a donation from Nick McCauley through his employer, which we greatly appreciate.

From an expense standpoint we bought inventory for the concession stand. We also bought bought hotel rooms for the wrestling team for an out of town tournament, along with paying our yearly fee to our website administrator

The total assets as of January 31, 2024 is **\$127,642.51**; this represents an increase in assets of \$5,151.54 from January 2024. For comparison, at this point last year (January 2024), we had **\$122,490.97** in assets.
